



## Participation, Release, and Consent Form

### **Permission to Participate**

I agree to hold Global Arts harmless against any liability, loss, or expense I incur or suffer as a result of participation in the music education program, including but not limited to, loss, injury, or expense in traveling to and from music lessons and program events. I understand that, as with any activity, there are risks. I therefore agree to assume these risks and to hold Global Arts harmless from any action or actions, suit or suits, in law or equity, which may be brought by any person or persons in connection with, or with reference to, the administration, planning, preparation, development, conduct, and execution of Global Arts' programs. I understand that my child will participate in Global Arts' music education program from the date of this Agreement until withdrawn.

By signing this form, I hereby release Global Arts and GALA's Community Partners, GALA's Board, administrators, directors, officers, teachers, employees, and volunteers from and against any and all claims.

### **Release of Information/Records**

I consent to Global Arts and its evaluation team obtaining access to my school and juvenile court records, if applicable. If applicable, I agree to allow my child's school to release its school records including grades, attendance, and discipline records to Global Arts's evaluation team. I understand that the GALA student will complete a confidential survey about his or her attitudes and opinions as part of an evaluation. I understand the information obtained will be statistically analyzed and that my child's name will be withheld for confidentiality purposes. I understand that this information, in addition to the survey, will be part of a larger evaluation and only the evaluation team and program staff will have access to this confidential information.

### **Medical Consent**

I understand that there are some risks inherent in the activities that are included in Global Arts's program, but willingly assume these risks in order to allow my child to participate. If I cannot be reached in the event of an emergency, I give permission for any care or treatment by a physician, surgeon, hospital, nurse, doctor's assistant or medical care facility that may be required.

### **Transportation**

I fully understand that transportation to and from Global Arts's field trips and other sanctioned activities is provided by only properly licensed and insured commercial carriers, with Global Arts named as an additional insured. I further understand that Global Arts staff members or teachers are never permitted to transport my child in any other vehicle, except in the event of an emergency. I authorize Global Arts's Executive Director, or their designee, to exercise their judgment in determining the existence of a transportation emergency and its safest and most logical resolution. I hereby release and hold Global Arts harmless against any liability, loss, or expense incurred or suffered in consequence of any action or actions, suit or suits, in law or equity, which may be brought by any person or persons in connection with, or with reference to, the administration, planning, preparation, development, conduct, and execution of Global Arts program.

### **Field Trips**

From time to time as part of the Global Arts curriculum, students will go off campus on field trips. They travel by car and/or school bus. Children are supervised by members of the GALA faculty as well as volunteer parents. Your signature below indicates that you child is authorized to participate in such school activities. *\*Students under 18 will not be allowed to participate in field trips without a permission slip.\**

### **Photography/Videotaping**
